

Required Financial Management Experience for the CDFM

Candidates must have the required number of years of defense-related financial management experience outlined below to earn the CDFM designation:

•Two (2) years if you hold an Associate's degree or higher; or •Three (3) years if you do not have a degree.

If you do not have defense-related financial management experience, you must meet the following criteria outlined below to earn the CDFM designation:

•You must have four (4) years of Federal government-related financial management experience; and

•An Associate's degree or higher.

CDFM Testing Using the G.I Bill

You can receive reimbursement for licensing and certification tests (e.g., CDFM tests) you take on or after March 1, 2001. (MGIB-AD, VEAP & DEA beneficiaries only.) Effective January 6, 2006 MGIB-SR & REAP participants became eligible for this program. These tests must be specifically approved for the G.I. Bill. VA can pay only for the cost of the tests, up to \$2,000.00, and not other fees connected with obtaining a license or certification. VA will pay for tests even if failed.

Transparency – Part 3 of 3

Ms Lori Tetla, the Chief of Financial Services, AFSOC/FMAS, prepared a paper on Transparency in Financial Management. Her paper is presented in a three-part series.

The first installment focused on technological changes brought by automated systems. The second part discussed the proliferation of information. The third side focuses on site owners managing the information.

In earlier presentations, we discussed the importance of analysts learning funds status relationships and database data elements. Next, we reviewed the pitfalls of information proliferation on the internet. Finally, we finish this article with discussion of managing information on the web.

During the internet information explosion, few probably envisioned the outdated data currency, and the inherent redundancy and duplication which exists. The Air Force utilizes knowledge management sites to distribute and share information, but we need to do a better job maintaining these information sites. How many times have you attempted to access a web site only to receive a message the link is invalid, or viewed a site and found the information to be outdated? When you realize the listed site owner separated or retired from federal service months or years prior, you realize the information may be outdated. If managed at inception, information sites can be well controlled and current; however, protocols for controlling sites were not initially well established or followed, resulting in information overload. This volume of invalid sites and outdated information will only continue to grow if not aggressively worked.

Naturally, time is wasted when obsolete or incomplete data exists. But worse, in dynamic, non-static disciplines such as fiscal policy, use of aged information may result in erroneous financial decisions which conflict with existing statutes. FM organizations at every level should identify knowledge sites associated with their unit, base, or command, and update or delete outdated information. Controls must be established to ensure data currency. The Financial Services Transformation may be the poster child for implementing controls at the outset. They incorporated regulation cross references which are keyed to provide updates to the Frequently Asked Questions posted on the customer self-service website. Take a few minutes to look at your own program, base, or MAJCOM information posted to the portal or other linked sites. Is the contact information and data presented still accurate and useful?

An authoritative source of financial information resides in service regulations. When the Defense Finance and Accounting Service was established, Air Force financial management regulations were significantly revised to reflect remaining functions and responsibilities. Most regulations and manuals were revised so greatly they became general "instructions," allowing more interpretation and application at the user level without being directive. This created a loss of valuable "how to" information, with many offices maintaining hard copy "obsolete" documents such as AFM 177-370, Base Level Accounting System BQ Manual and other key regulations. No longer do we have the manual pen and ink posting process of years past: now Service publications and timely updates are on electronic publication sites. Yet the guidance in current AF FM publications still contains outdated references to deleted reports, terms, and processes, which is further complicated by the number and speed at which transformation efforts in our career field are occurring. While Communities of Practice (CoP) and other collaboration tools aid in getting information to the field timely, action is still needed to ensure timely updates to regulations. This is not an easy task, but it must be accomplished.

Preventing information overload, and conflict between collaborative and published sources, can only be achieved by ensuring this data is current. This can be achieved by encouraging functional users at all levels to take ownership of these publications and forward suggestions for changes or additions to the appropriate regulation Office of Primary Responsibility (OPR). In turn, the OPRs must research proposed changes and make timely updates as needed. A good example of where this has been successfully employed is the new AFI 65-116 MIPR guidance. SAF/FMP, Air Force Accounting and Finance Office, identified a lack of understanding and compliance of MIPR requirements. Interim detailed

guidance was distributed to the field via the AFAFO CoP until a detailed and comprehensive Air Force Instruction was formally published. Updates continue to be made in a timely manner as the DoD emphasis on interagency orders and identification of eliminations for financial reporting continues to evolve.

The use of metrics goes hand in hand with transparency. Within our own FM community, full and open disclosure of financial information is supported by increased accessibility and visibility of metrics reporting through use of the AF FMSuite Dashboard. This Commander's report tool already provides a MAJCOM/Wing Financial Scorecard on several financial management indicators, to include vendor interest penalties per million, RTS Open Debts (non-DTS orders), O&M execution, and Dashboard usage, just to name a few.

Yet as we move towards using the dashboard as a "one-stop shopping" assessment on the health of financial operations, we continue to face obstacles in process improvement, reporting timeliness, and data accuracy. Every month, Quality Assurance Managers validate the data reported and identify disconnects to the Air Force OPRs. In some cases metrics are only reported at "summary" level, impairing our ability to validate the supporting detail. Continuing analysis is also required to determine if the right data is being measured and if the correct standards are being set to achieve desired results. Finally, a proliferation of metrics can result in information overload or a misguided concentration on improving metrics for metrics sake. Metrics are most certainly useful in identifying and monitoring volatile processes but care must be taken not to overuse or overanalyze operations to the point of being counterproductive.

As Financial Managers, we are tasked by our senior leaders to identify areas for improvement and act upon these ideas. As we continue to press forward with financial transformational changes on a massive scale, a pause to evaluate these changes may yield beneficial and synergistic results. Dramatic strides in technology have also produced unanticipated and unintended consequences and hamper the effectiveness of transparency. In the continued quest for bigger and better processing tools, we must not forget the basics of our financial management discipline.

In summary, we can further capitalize on the advancements made with automation by capturing and communicating basic financial management functional knowledge in preparation for emerging ERPs; maintaining accurate, timely, and pertinent site information; taking ownership and responsibility to update service functional instructions and manuals; and carefully managing

established metrics. Some of these building blocks are proven through the test of time (i.e., regulations and guidelines), while computer software and internet search capabilities are relatively new. Regardless, these sources are recognized references for financial managers, and as such, must be given a priority to ensure their currency, understandability, and applicability.


