






Rapid Acquisition is HERE!

Did you know that Dr. Roper, Assistant Secretary of the Air Force (AT&L), has challenged Acquisition personnel to start thinking outside of the box? The usage of Other Transactional Authority (OTA) is nothing new; however, this authority has not been overly utilized. In order to assist everyone with gaining a better understanding of how to utilize this authority in the best interest of the government Eglin's ACE has started to implement a number of training seminars to get the information out. Usage will need to be coordinated through the Contracting Office to have an Agreements Officer administer the program or one of the many consortiums that are already established may be able to be utilized!




Certified Defense Financial Management (CDFM) Updates

The current EDFMTC textbook (v 2013a) will continue to be sold and used in classrooms through August 31, 2018.

The new EDFMTC textbook (v 2018a) will be available for purchase on <u>July 1, 2018</u>, and introduced in classrooms on October 1, 2018.

New forms of the CDFM (Modules 1-3) exams will be available on 1 Sep 2018. Current exams for Modules 1-3 will remain available and run through 31 Dec 2018.
