National Defense Authorization Act (NDAA) Emergency Funding by Kathryn at ASMC HQ

The House (as well as the Senate) version of the National Defense Authorization Act (NDAA) moved the \$9 billion included under the category of "Emergency" funding that was contained in the President's submission of the FY2020 Defense Budget to DoD's "base" budget. Since the movement of these funds to the base budget exceeds the current Budget Control Act thresholds, Congress will need to develop a deal to raise the caps or risk triggering sequestration. Budget Control Act at risk of disappearing after 8 years on Capitol Hill by Federal News Network

The Budget Control Act has been a defining feature of the federal fiscal landscape for eight years. Suddenly, it's on the verge of disappearing for good. The House approved a two-year budget deal last week that does away with the last vestiges of the BCA caps, and the Senate is set to vote on the deal this week. Treasure Hunts are Real!

Did you know that YOUR unclaimed money or property can be held by the U.S. Treasury? Well, *yes*, and this is why it is time to go on a real life Treasure Hunt to find those unclaimed deposits or refunds rightfully owed to you!

Military, contractors, and civil service members move around quite often due to promotions, reassignments, Permanent Change of Station (PCS), layoffs, new job opportunities, family reasons or retirement. For example, commanders have to move every two years and the average military member might have to move every three or four years for stateside. For contractors, they might have to leave their current job because a contract option year has ran out and a new company might have won the next contract. Further, our civil service members have opportunities to grow within or outside their career fields by taking a PCS opportunity and relocating. As these moves take place, families, more often than not, may forget about that small deposit or refund that was owed to them prior to a transfer of duty location. With that said, does that make you wonder if you have money out there from a utility deposit, a refund, or had a check that you never deposited?

Wonder no more! There are data bases that you can start searching to identify owed deposits or refunds that are in your name, ready for the taking! One data base you can use is the *missingmoney.com* websites. If you identify unclaimed funds owed to you while searching these data bases, go to the *unclaimed.org* website and locate the U.S. Treasurer of that state the funds are in. Once at the U.S. Treasurer's website, you can look to claim your owed funds online or by mail depending on that state's requirements. For example, in Florida, go to fltreasurehunt.org to claim YOUR money.

HOWEVER, be careful when doing your research where that source is looking to attempt to charge you to claim your money. Likewise, don't pay to register to look for unclaimed funds. There are legal agencies like Law Offices that are valid however they will charge you a fee. For Example, I received a letter stating I had \$99 available and for a \$10 fee the company will file the paperwork. Yes, that is legal, and a valid source! But why pay someone money when I can file the claim with no fee! So my recommendation is to claim it free from the official U.S. Treasurer site.

I like hearing from people on what they were able to claim so be sure to keep me posted! Happy treasure hunting!

F-35 transported via C-17
