Hurlburt Field, home to HQ Air Force Special Operations Command (AFSOC), is working towards the goal to achieve budget audit readiness on the Statement of Budgetary Resources by Sep 2014 and full audit readiness by Sep 2017. The Secretary of Defense directed DoD to obtain an unqualified (clean) audit opinion that conforms to Generally Accepted Accounting Principles (GAAP). In layman's terms, all government internal controls will be "tested" and "validated" before an official external FIAR audit occurs.

Lessons Learned from audit testing at Hurlburt Field are listed below:

- SAF/FM mandated a new AF Form 1269, "Request for Target Load or Change".
- Delegation Authority Letters must have full name and job title authorizing individuals to process the AF Form 1269.
- SAF/FM submitted the "Funds Distribution to Base" audit readiness assertion to OSD. As a result, AFSOC units are required to reconcile annual/quarterly authority with supporting documentation by the 10<sup>th</sup> of every month beginning March 2013 (AFI 65-601 V2 Budget Management for Operations).
- Reimbursable Budget Authority (RBA) testing identified policy and processes that do not meet the intent of the FMR. A valid customer order identifies the customer, amount, method of payment, financing source or fund citation, delivery requirements, duration of agreement, and document number. All non-sensitive customer orders must be loaded into FMSuite Open Documents.
- In July 2012, AFAFO issued policy on customer orders. MIPRs or Project Orders must be used to fund reimbursable customer orders to AF activities located on different installations. MORDs and AF 616s cannot be used for reimbursements.
- The automated Time and Attendance reporting system for civilian pay will require CAC enabled signatures on all time cards.
  - AF level is in the process of reviewing civilian pay policy for accomplishment of AF Form 428, "Request for Overtime, Holiday Premium Pay, and Compensatory Time".
  - The DD Form 577 appointment is now required for anyone who signs civilian time cards, and other civ pay supporting documents include leave requests, OPM Forms 71, AF Forms 428 and AF Forms 3821.

#### Financial Improvement and Audit Readiness (FIAR) Lessons Learned

- Military Pay testing showed there was not a standard process across the Air Force for tracking and processing station gains for military members.
- "Separation of Duties" is absolutely mandatory for AF Form 1269s and all financial documents. The same individual must not prepare and approve a document in ABSS. All key duties such as authorizing, approving, and recording must have an electronic/digital signature from three separate individuals.

What can you do to become FIAR ready? Read your current Air Force Instructions (AFIs) and identify processes that do not make sense to the MAJCOM FIAR focal point. Also, financial managers must maintain readily available documentation on the status of equipment, materiel and personnel. Do not "pencil whip" or just "wing it". Most importantly, ask questions because processes are constantly changing.

In closing, manage appropriated funds with integrity and accountability to demonstrate proper stewardship to Congress and the American taxpayers.
