PDI CDFM Training/Testing

Pre-Conference Training Sessions

Two special pre-conference sessions will be held on Monday and Tuesday, May 25-26, and will include intense coverage of examination Modules 1, 2 and 3. Each session will have two highly qualified instructors with extensive experience teaching the 5-day EDFMTC. These two-day events are intended for those who (1) are enrolled in the CDFM Program, (2) have completed a significant amount of exam preparation, and (3) wish to "top off" their knowledge prior to taking the exam at the PDI. continued Module 2 and on Tuesday you'll choose between Module 2 and Module 3. While you'll only be able to attend two module sessions, you will be in control when it comes to deciding which modules to attend. Separate registration for these preconference events is required and will cost an additional fee of \$200. This optional two-day event is offered as a package and you are expected to attend and pay for both days. PDI 2009 registration is required in order to attend this training.

A second set of pre-conference sessions will be held on Monday, May 25 and continue through Tuesday morning, May 26. The sessions will include intense coverage of the optional CDFM Module 4 examination (Acquisition). These sessions will be taught by two experienced teachers, one formerly a professor at the Defense Acquisition University and the other a current DAU instructor. This 1-1/2 day event is intended for those already in the CDFM Program (whether you already hold the certification or not) and have elected to pursue the designation "CDFM with Acquisition Specialty." Separate registration for this pre-conference event is required and will cost \$150. PDI 2008 registration is required in order to attend this training.

May 26 - May 29

All CDFM examinations at the PDI will be delivered via computer and special authorization and purchase procedures apply. All individuals wishing to complete an exam (\$95 each) must be pre-enrolled in the CDFM Program and have their candidate ID. These "Special Arrangement" exams will require special preauthorization by the CDFM staff.

Please send your request for PDI examination(s) to Jessika Kilgore (kilgore@asmconline.org) stating the exam module(s) you wish to complete and when you wish to complete it (date and time). If you have other certification questions not related to PDI testing, please contact Shelly Johnson, Certification Assistant, at Johnson@asmconline.org. Exams will be offered at 8:00 AM, 10 AM, 1 PM and 3 PM each day (Tuesday, Wednesday, Thursday and Friday). Testing is not available at 3 PM on Friday. Space may be limited so please sign up early. (We encourage you to test on Tuesday or Wednesday if possible as past experience shows that Thursday and Friday is usually 100% subscribed and not available for "last minute" scheduling.)

You will be sent specific exam purchase instructions 7-10 days prior to the PDI. Do not purchase an examination until after you've received specific instructions from Ms. Claudia Carr, CDFM-A (ASMC Certification Director).

New Defense procurement chief lays out priorities

By Elizabeth Newell, Government Executive, 30 April 2009 With just four days under his belt, the Pentagon's new head of acquisition is sifting through the massive job ahead of him and establishing a to-do list that includes reviews of major procurements.

Ashton Carter, sworn in as undersecretary of Defense for acquisition, technology and logistics on Monday, said Thursday that much of what would have been his first order of duty was accomplished during the lead-up to Defense Secretary Robert Gates' release of the department's budget request in early April. Gates recommended major changes in the Pentagon's procurement priorities, including cuts to a number of programs.

Nonetheless, Carter said examining troubled programs and acting on Gates' plan is his first priority. The new acquisition chief plans to review all the department's projects gradually to ensure they are being properly executed.

His second focus will be on logistics, an area he said sometimes is overlooked. With two ongoing wars and a major shift in combat operations, Carter said, attention to logistics will be crucial.

"What's ringing in my ears is the secretary of Defense's oftenexpressed frustration that the troops are at war but the building as a whole is not," Carter said. "I don't want him to feel that way about his acquisition operation and logistics operation."

Among the greatest challenges will be refocusing resources from Iraq to Afghanistan in President Obama's timeframe. "We have quite a lot of stuff to move out of Iraq and into Afghanistan ... that's a non-trivial matter both to conceive and to execute, and we can't afford not to meet those timetables," Carter said.

Acquisition reform will be another priority, he noted. Carter already is looking into the appropriate role of contractors "from Blackwater security in theater to pink badges at the Pentagon" and said he wants to improve the government's ability to acquire products quickly.

Presidential and congressional interest in reforms will be an asset. "If it is going to be different than other efforts at acquisition reform, it's going to be because of that constellation of people who are interested in taking some risk to do things differently if they can see the payoff," Carter said.

Carter acknowledged the acquisition workforce challenges are "formidable" in a range of Defense offices, including his own. While building a robust, qualified staff will not happen overnight, he said, it is crucial to begin making strides. "It's a big job to spend this much money on things that are so complicated in such a novel way," he said. "Nobody else buys things the way the United States government buys things, so it's an art to do it right, and you need a lot of the right people."
